A RESOLUTION FIXING A TIME AND PLACE AND PROVIDING FOR NOTICE OF A HEARING BEFORE THE GOVERNING BODY OF THE CITY OF KINSLEY, KANSAS: AT WHICH THE OWNER DONALD CALLAWAY HIS OR HER AGENT, LIENHOLDERS OF RECORD AND OCCUPANTS OF THE RESIDENCE LOCATED:

Commencing at the Northwest corner of Block Twenty-five (25), in the City of Kinsley, being also the corner of Marsh Avenue and Sixth Street; thence East along the South line of Sixth Street, 23' and 5 and 12" for a place of beginning; thence South 71' and 3"; thence East 6 1/2"; thence South 58 and 9", more or less, thence East 23 1/3'; thence North 130,' thence West 23' and 10 1/2" to the place of beginning in the City of Kinsley, Kansas

Commencing at the Northwest corner of Block Twenty-five (25), in the City of Kinsley, being also the corner of Marsh Avenue and Sixth Street; thence East along the South line of Sixth Street, 23' and 5 and 12" for a place of beginning; thence South 71' and 3"; thence East 6 1/2"; thence South 58 and 9", more or less, thence East 23 1/3'; thence North 130,' thence West 23' and 10 1/2" to the place of beginning in the City of Kinsley, Kansas

MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURE SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS AN UNSAFE OR DANGEROUS STRUCTURE.
