Witt to compete in Home Run Derby at All-Star Game

Bobby Witt Jr. has announced that he will participate in the Home Run Derby at this year's MLB All-Star Game in Arlington, Texas.

The derby will be held July 15 at 7 p.m. on ESPN. The All-Star Game is slated for July 16.

Witt, a Colleyville, Texas, native grew up just north of Arlington, home of the Texas Rangers and the franchise his dad, Bobby Witt, was with for 11 of his 16 seasons pitching in the Major Leagues.

Witt was the fourth player to announce his spot in the eight-player field along with Orioles shortstop Gunnar Henderson, Phillies third baseman Alec Bohm and Mets first baseman Pete Alonso.

Witt will become the fifth Royal to participate in the Home Run Derby and first since Salvador Perez in 2021. The other Royals who have participated are Bo Jackson (1989), Danny Tartabull (1991) and Mike Moustakas (2017).

Witt leads the Royals in numerous batting categories, including

batting average (.324), home runs (15), runs (72), RBI (61) and stolen bases (22).

Throwing to Witt in the derby will be his brother-in-law James Russell, a former big-league reliever who pitched for six seasons with the Cubs and parts of two others with the Braves and Phillies.

KU football program takes stage at Big 12 Media Days

Kansas football head coach Lance Leipold, quarterback Jalon Daniels, running back Devin Neal, cornerback Mello Dotson and defensive end Jereme Robinson will preview the 2024 football season at Big 12 Media Days at Allegiant Stadium in Las Vegas, Nevada, on Wednesday.

Big 12 Media Days is a two-day event, beginning on Tuesday with portions

streaming live on ESPN+ and televised on ESPNU. Kansas will participate in Big 12 Media Days on Wednesday along with Arizona, Baylor, BYU, Colorado, Houston, UCF and West Virginia.

Arizona State, Cincinnati, Iowa State, Kansas State, Oklahoma State, TCU, Texas Tech and Utah took the stage Tuesday.

Leipold, Daniels, Neal, Dotson and Robinson will meet with the media in

various capacities throughout the day, including appearances on ESPNU at 1:05 p.m. while Leipold will hold his press conference at 1:20 p.m. Leipold's press conference will stream live on Big 12 Now on ESPN+.

Kansas enters the 2024 season following back-to-back bowl appearances for the second time in program history and the first time since 2007-08. The Jayhawks finished the season at 9-4, the most

wins by a Kansas team since 2007, and return a star-studded roster entering the 2024 season.

The Jayhawks will play all six home games in the Kansas City metro area as work continues on the University of Kansas Gateway District. Fans can purchase the 2024 Kansas football four-game season ticket package that includes all home games at GEHA Field at Arrowhead Stadium. The season ticket

package features prices starting as low as \$230 for general stadium seating.

Other ticket options include the Family Zone as well as available premium seating opportunities. A six-game season ticket packages which include the first two games at Children's Mercy Park are sold out.

Single game tickets to the contest played at GEHA Field at Arrowhead Stadium will become available early-August.
