Trapping

This week I wanted to talk about the sport of trapping. If someone comes to me and tells me they want to get into trapping, the first thing I am going to tell them is to read our regulations and find a veteran trapper that you can ride along with to learn the tricks of the trade. Before you start trapping you need to obtain your furharvester education certificate and then buy your furharvester's license. Once those are in your possession you can start trapping on your own. There are so many things to cover when it comes to trapping there is just no way I can cover them all in a paragraph. So, what I am going to do is hit the high points of what trapping laws we see violated the most. By far the most common violation is not checking traps daily. When you run a trap

line, it is your responsibility to check your traps daily so any animal you have caught in your traps won't suffer. The second most common violation in trapping is someone not tagging their traps. This is usually because someone is setting traps where they aren't supposed to be (trespassing) or they were too lazy to put a tag on their trap. All in all, trapping is a very cool sport, and it appears to be slowly dying off. We, as outdoorsmen, need to do something about it. Why, you ask? For starters, most of the things we catch in traps like to eat eggs they find in nests. Things like Turkey and pheasant eggs. FINAL PERFORMANCE PUBLIC HEARING NOTICE CDBG

Water Tower Project

The city of Cawker City will hold a final performance public hearing on March 12, 2025 at 7:30 pm, at the Cawker City City Hall at 804 Locust St., Cawker City, Kansas, for the purpose of evaluating the performance of Grant No. 22-PF-015 which was proposed to construct a 75,000-gallon steel pedesphere water tower and demolish the existing tower; water system improvements consisting of, but not limited to: excavation, earthwork compaction, concrete work, tower construction, connecting to existing piping, installing two

(2) 6" gate valves, 100 linear feet of 6" PVC piping, demolition, and purchase & installation of one fire hydrant. Additional activity including geotechnical investigation, mobilization, sign construction, highway crossing, legal fees, environmental assessment, construction staking, erosion control, grass seeding, creative design and painting, other professional services if required; cultural study, asbestos inspection and removal, lead inspection and removal, and engineering; design, and inspection. The proposed project also included grant administration. All quantities listed are approximations.

The project as completed included, construction of a 130'-tall 75,000-gallon, single pedestal-gallon, welded steel water storage tower; the removal of a 75,000-gallon, multileg, welded steel water tower and associated infrastructure; and the installation of

100 linear feet of underground piping, two 6" valves, and related appurtenances. Additional project items included traffic control, mobilization, demobilization, engineering design and construction inspection, and grant and loan administration.

The total project cost was \$1,114,206.25 with \$454,250.00 in CDBG funds utilized. This grant was funded, all or in part, from the Kansas Department of Commerce, Small Cities Community Development Block Grant (CDBG) funds. All aspects of the grant will be discussed and oral and written comments will be recorded and become a part of the city of Cawker City CDBG Citizen Participation Plan. Reasonable accommodations will be made available to persons with disabilities. Requests for accommodations should be submitted to the Cawker City Clerk by March 8, 2025.
