## **Court Overturns Lesser Prairie-Chicken Rule in Major Win for Kansas Counties**

In a decisive victory for Kansas landowners and local government, the U.S. District Court for the has struck down the U.S. Fish and Wildlife Service's burdensome "4(d) rule" imposed under the Endangered Species Act for the lesser prairiechicken.
