KBI arrests law enforcement office for child sex crimes FORD COUNTY—Agents with the Kansas Bureau of Investigation (KBI) arrested a Kansas law enforcement officer for child sex crimes. On Friday, May 30th, just before 7:00 a.m., KBI agents arrested 42-year-old Erik Lalicker. Lalicker was arrested for seven counts of sexual

Enforcement Agent. Lalicker is currently on administrative leave pending the investigation. The KBI Child Victims Unit began investigation after a cyber tip was submitted to the National Center for Missing and Exploited Children (NCMEC). Following the arrest, Lalicker was booked into the Ford County Jail on a \$75,000.00 bond. All subjects are presumed innocent until proven guilty in a court of law. Anyone with information related to this investigation is asked to call the KBI at 1-800-KS-CRIME. Anonymous tips can be submitted online at www.kbi.ks.gov/sar. The investigation is ongoing. Suspect who shot KC area officer multiple times captured in Ellis County

ELLIS COUNTY—The Kansas Bureau of Investigation (KBI) canceled the Kansas Blue Alert that was issued after law enforcement were searching for a suspect believed to have shot a Lee's Summit police officer on Sunday night, June 1st, according to a media release from the KBI. The alert was canceled on Tuesday morning, June 3rd, after Thomas Eugene Tolbert, 27, was located and apprehended in Ellis, Kansas. In the early morning hours of June 3rd, the Ellis Police Department received a tip via CrimeStoppers that the suspect, identified as Thomas Tolbert, was staying at the Days Inn Hotel, located at 205 Washington Street in Ellis, according to a press release from the Ellis Police Department. The Ellis Police officer on duty requested that the CrimeStoppers tip line get in contact with Ellis County Communications to gather the most accurate information and broadcast it out to area law enforcement units. All available units were requested to respond to the City of Ellis so that a plan could be devised to verify the integrity of the tip that was received, the release said. At about 2:42 a.m., Ellis County Communications received additional information from witnesses who reported giving Tolbert a ride from the Kansas City, Missouri area. They stated they were enroute to Colorado and had been asked by a third party to transport Tolbert, unaware of his connection to the Blue Alert, the release said. According to the witnesses, Tolbert provided a false name and began acting suspiciously during the trip. Upon stopping to rest for the night, one of the witnesses saw the Blue Alert on social media featuring Tolbert's image and immediately contacted law enforcement. At 2:45 a.m., the Ellis Police Department requested activation of the Hays Police Department's Special Situation Response Team (SSRT). Members of the Kansas Bureau of Investigation also responded to the scene. At 4:39 a.m. SSRT began evacuating adjacent hotel rooms. Officers from the Hays Police Department, deputies from the Ellis County Sheriff's Office and KBI agents arrived at the hotel and safely took Tolbert into custody at 4:40 a.m. The KBI said Tolbert was arrested on a Missouri warrant for assault first-degree or attempted serious physical injury, armed criminal coaction, unlawful possession of a firearm, resisting arrest or detention by fleeing, and second-degree domestic assault. He was booked into the Ellis County Sheriff's Office Jail. (Hays Post)

Water rescues after heavy rains cause flash flooding in Kansas

WICHITA—Heavy rains caused flash flooding in the Wichita area of south-central Kansas, forcing firefighters to rescue dozens of people including stranded motorists. Sedgwick County's Emergency Management Director, Julie Stimson, said at a briefing on Tuesday night, June 3rd, that the County had received anywhere from one and one half inches to seven inches since Monday, June 2nd. She warned motorists who run into flooded areas not to drive around barricades and emergency vehicles and to turn around instead. Kansas Governor Laura Kelly issued a disaster emergency declaration to enable state agencies to provide assistance. The Wichita Fire Department used boats to rescue several motorists trapped in their cars. While the water sometimes reached windshield height, some people still attempted to drive through it. With more rain in the forecast officials warned that the soil in the area is saturated and even an inch or two of rainfall could lead to localized flooding. (Hays Post)

Crawford, in Salina in reference to a damage to property, according to Salina Police Captain James Feldman. The suspect then started a fire in the area of the window, damaging some window trim and carpet just inside the damaged window. No entry was gained into the building. can contain more seeds than wheat heads, and cattle can graze its leftleaves, stems, and regrowth, and it grows back each year because it is a perennial.
