Wheatland Electric Donates to Zenda for Christmas Lights



That a hearing will be held on the 12th day of May, 2025, before the governing body of the city at 6:30 p.m. at City Hall, 201 W. Main, Harper, Kansas 67058 at which the owner, his or her agent, any lienholders of record, any occupant and any other parties in interest, as that term is defined by law, of the structure located at:

West half of Lot 03 and all of Lot 04 in Block 06 of the original addition in the City of Harper Harper County, Kansas

may appear and show cause why such structure should not be condemned as an unsafe or dangerous structure and ordered repaired or demolished.
