organizations on Dec. 1, 2012. Since then, the application process has been moved internally and is currently handled directly by WEC. This year, WEC and CoBank have once again

each contributed \$10,000 to the fund. The program will continue to run until the funds are exhausted. Since 2012, WEC's Sharing Success Fund has made \$165,000 available to community-based organizations and projects across their service territory.

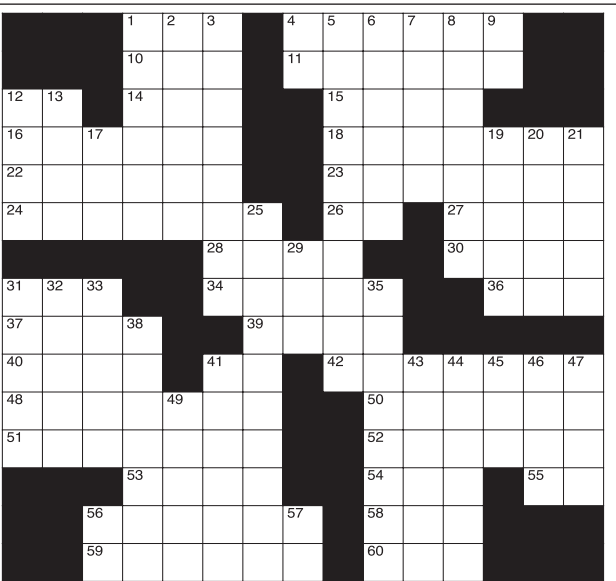

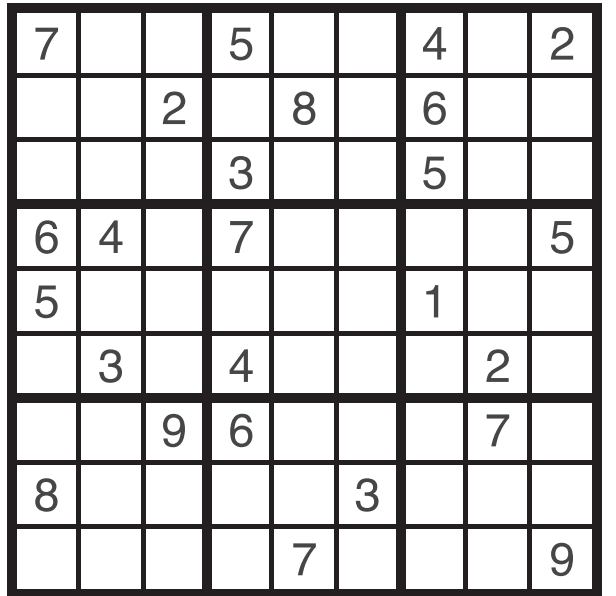

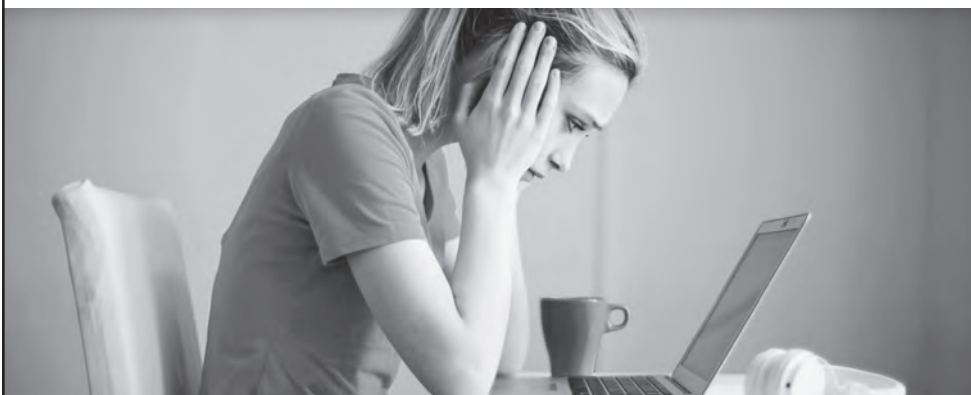
