Edwards resigns due to comment backlash

COFFEYVILLE — A Coffeyville city commissioner has resigned following public outcry over a comment he made on a private social media page earlier in the week.

Commissioner Don Edwards submitted his letter of resignation on Saturday morning to his fellow commission-

In addition to resigning from his commission seat immediately, Edwards said he will ask the Montgomery County Clerk to remove his name from the general election ballot in November. Earlier in the week, Edwards announced he planned to seek re-election.

Edwards' decision to leave his commission seat came after social media commenters went in a tirade over a post that Edwards made on his private Facebook page on Thursday.

In that post, Edwards wrote, "I ran to the aquatic center this evening to pop my head in and meet the new pool manager and tell her she's done a great job getting the place ready. As I was walking up, a couple of young boys were leaving and I asked them if the water was cold and one of them said, 'Yes! As soon as I jumped in, my nipples got hard" I asked them if that happened to the girls, too, and they just giggled and ran off.'

After social media commenters accused Edwards of making sexually harassing comments about young women, Edwards returned to his social media page to apologize.

Ownership transfer planned for 1949 hospital building

COFFEYVILLE — Ownership of the Coffeyville Regional Medical Center's original 1949 building cleared a first hurdle on Tuesday.

Coffeyville city commissioners voted unanimously to transfer ownership of the 1949 property to the CRMC Inc., after the structure was vacated in the past month. Commissioners reflected their decision in the first reading of an ordinance. A second and final reading of the same ordinance will take place at the commission meeting on June 24.

The agreement that dates back to 1949 calls for the City of Coffeyville to maintain ownership of the original hospital structure and have it overseen by a CRMC Board of Trustees. Members are appointed by the Coffeyville City Commission.

The lease agreement comes with a nominal fee: a \$1 yearly payment from CRMC, Inc., to the City of Coffeyville.

Ben Brubaker, city manager, said the City of Coffeyville used its Home Rule Power to dissolve the governance of CRMC and transfer the ownership to CRMC Inc. Coffeyville Regional Medical Center's business operations are not controlled by the City of Coffeyville. Instead, it is operated by the CRMC, Inc., which is a nonprofit organization. Turning over governance of CRMC's 1949 facility will be controlled by the CRMC Board of Directors. That transfer will eliminate the need for the City-appointed Board of Trustees, Brubaker said. The official transfer of the 1949 property will be triggered when a a second reading of the ordinance is approved and an ordinance summary is printed in the Montgomery County Chronicle, which serves as the official legal notice newspaper for the City of Coffeyville. COFFEYVILLE — A former Coffeyville city commissioner was appointed to fill the commission seat left vacant by the resignation of Don Edwards.

Vice Mayor Ann Marie Vannoster said the commission should choose someone with experience.

So, they appointed former commissioner Pam Jones to fill Edwards' vacant seat.

The decision was made at Tuesday's Coffeyville City Commission meeting.

Jones last served on the commission in 2023 when she finished the term of former commissioner Justin Doane, who resigned after moving to Oklahoma.

Coffeyville's mayor expressed glee that 11 local eyesores — two of which are large-sized structures — will soon face the wrecking ball.

City commissioners agreed to accept a \$137,000 bid from Swindell Excavation for the demolition of 11 condemned structures. Two of the structures have been the subject of community concern for many years, including the former West Side School Gymnasium at 502 Fresno and the conglomeration of structures at 816 Illinois, said Matt Conger, director of facility services.

did not die down with his apology. Mayor Deborah Maples issued an official statement saying Edwards' comments did not reflect the values of the City of Coffeyville.

By Saturday morning, Edwards said the overall social media outcry was too great to overcome.

"I was not asked to resign," he told the Chronicle. "I'm doing this because I think it's the right thing to do for the City of Coffeyville."

In his resignation letter, Edwards again apologized for his comments.

"The comment in question has caused a lot of upset in our community and is distracting from the many positive things happening at the City of Coffeyville," he wrote. "I have nothing but love in my heart for my hometown of Coffeyville and want nothing but the best for people happy," noted Mayor Deborah Maples when talking about the eventual demolition of the problematic properties.

Other properties to be demolished include structures at 207 W. 2nd, 1312 Read Street, 1306-1308 Read Street, 1320 S. Maple, 1815 W. 6th, 507 E. 10th, 916 Minnesota and 507 Jasper.
