**CITY OF LEWIS, KANSAS ORDINANCE NO. 371**  
**AN ORDINANCE OF THE CITY OF LEWIS, KANSAS, PROHIBITING THE PARKING OF HEAVY TRUCKS AND TRAILERS ON CITY STREETS TO PREVENT DAMAGE TO MUNICIPAL INFRASTRUCTURE, AND PROVIDING PENALTIES FOR VIOLATION**

WHEREAS, the Governing Body of the City of Lewis, Kansas, finds that the parking and

operation of heavy trucks and trailers on city streets cause significant deterioration of pavement, curbing, and storm-water structures not designed to carry such loads; and

WHEREAS, the cost of maintaining and repairing such damage places an undue financial

burden on the citizens of Lewis; and

WHEREAS, the City desires to protect its infrastructure and ensure the longevity of its street

system through reasonable parking restrictions;

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LEWIS, KANSAS:**

**SECTION 1. PURPOSE.**

The purpose of this ordinance is to preserve the condition and useful life of City streets and

related infrastructure by restricting the parking of heavy trucks and trailers on streets not

constructed or intended to bear such weight.

**SECTION 2. DEFINITIONS.**

For purposes of this ordinance:

1. "Heavy Truck" means any motor vehicle, with or without a trailer, having a gross vehicle weight rating (GVWR) of 15,000 pounds or more.

2. "Trailer" means any trailer designed to be drawn by a motor vehicle and constructed so

that part of its weight rests

upon or is carried by another vehicle.

3. "City Street" means any publicly paved street, or paved roadway under the jurisdiction

of the City of Lewis.

4. "Parking" means the standing of a vehicle, trailer, or combination of vehicles/trailers

over 15,000 pounds are not permitted to park on paved city streets for a period of more than 60 minutes.

**SECTION 3. PROHIBITION OF PARKING HEAVY TRUCKS AND SEMI-TRAILERS.**

(a) No person shall park, or leave standing any heavy truck, trailer, or tractor-trailer combination weighing more than 15,000 lbs. on any paved city street, or right-of-way within the City of Lewis, Kansas.

(b) This prohibition applies whether the vehicle is loaded or unloaded.

(c) The only exceptions to this prohibition are:

1. Temporary parking for loading or unloading goods at a location directly abutting the street, provided such parking does not exceed 60 minutes.

2. Emergency vehicles or utility service vehicles while performing work on behalf of the City or a utility company;

3. Vehicles operating under a special permit issued by the City for construction, repair, or community events.

**SECTION 4. FINDINGS AND DAMAGE JUSTIFICATION.**

(a) The Governing Body finds that the asphalt and base structure of most city streets within Lewis were designed for passenger vehicles and light trucks only.

(b) The repeated parking and movement of vehicles exceeding 15,000 pounds GVWR causes premature cracking, rutting, and base failure, increasing maintenance and replacement costs to the City.

(c) It is therefore necessary, in the interest of fiscal responsibility and preservation of public assets, to restrict the parking of heavy trucks and trailers on paved city streets.

**SECTION 5. ENFORCEMENT AND PENALTIES.**

(a) Any law enforce officer or other authorized City of-

ficial may issue a citation for violation of this ordinance.

(b) Each violation shall be subject to a fine as follows:

**Offense/Fine**  
 First offense/\$250

Second offense (within 12 months)/\$500

Third and subsequent offenses/\$750 plus towing and impoundment at owner's expense

(c) Any vehicle parked in violation of this ordinance may be towed and impounded at the owner's expense, without further notice.

**SECTION 6. POSTING OF SIGNS.**

The City shall post signs at key entrances to the City and other appropriate locations reading

substantially as follows:  
**NO SEMI OR HEAVY TRUCK PARKING ON CITY STREETS - FINES UP TO \$750**

**SECTION 7. SEVERABILITY.**

If any part of this ordinance is declared invalid, the remaining sections shall remain in full force and effect.

**SECTION 8. EFFECTIVE DATE.**

This ordinance shall take effect and be in full force from and after its passage, approval, and publication as provided by law.

**PASSED AND APPROVED** by the Governing Body of the City of Lewis, Kansas, this 12 day of Jan., 2026.
