About HB 2114 — 2025-2026 Legislative Session

HB 2114 authorizes the Kansas Chief Engineer to adopt new rules and regulations under the Watershed District Act, specifically related to dam inspections, permitting, and associated fees. Under this bill, the Chief Engineer would have authority to:

- Increase fees for dam inspections
- Raise annual permit fees
- Require certified engineering inspections for Class A dams that were not previously subject to this requirement

The costs resulting from these changes and other associated cost affected would be funded through increased property taxes within watershed districts.

HB 2114 has already passed the Kansas House Substitute with a vote of 103 Yea to 13 Nay.

We encourage concerned citizens to contact their Kan-

sas State Senators and Kansas State Congressman to voice opposition to this bill.
