The bidding was certainly not scientific – in effect North bid a grand slam on the assumption that the three aces shown by South in response to Blackwood would be all that was needed to produce 13

It's hard to quarrel with North's assumption, since South made the grand slam - although she must have suffered a severe shock upon finding herself declarer at seven spades without a trump in her hand!

West led a heart, won by dummy's queen, and declarer cashed five trumps and the king of hearts, producing this six-card position: North

South – who had started with only 12 tricks and was hoping somehow to acquire a 13th - now led dummy's seven of spades, placing East under extreme pressure. It didn't matter whether East discarded a heart, a diamond or a club whatever East chose would establish declarer's 13th trick, so the grand slam, worth 2,410 points, came rolling home.
