growing community even better.

"Let us celebrate what this new facility means – not just for those who will work within its walls, but for every resident who will benefit from the healthcare services it will support," Swords said.

Shruti Chhabra, the Finney County Health Department's Director, was unable to be at the groundbreaking ceremony as she was at a Governor's Health conference. So she entrusted FCHS business manager Sandra Carabajal to speak on her behalf and provide Chhabra's thoughts on the groundbreaking.

"For years, our team kept showing up; patients in every tiny space, entire families crammed into a single room...nutrition and breastfeeding support in borrowed spaces," Chhabra said. "Everyone from our country commissioners to the person no one knows by name kept their end and gave us a million reasons to keep

The new building will be a promise fulfilled Chhabra said, a space to respond to the real lives and needs of the community.

"Thanks to the vision and investment of our county leadership and the generosity of our public," she said. "We now have a home that matches the heart and purpose of our work. We can't wait to expand our reach even further – and serve our county even better."

The construction is

tentatively looking to be completed September 2026. The new facility is located on the southwest corner of Eighth and Mary Streets.

The work is the latest project in Garden City and Finney County. An additional Station 3, to house the Garden City Fire Department and Finney County EMS, had a grand opening on July 1. That facility is located on the east side of Garden City at Shulman Avenue and Jennie Barker Road.
