

Everyone deserves due process

What I've found so disturbing about efforts to deport noncitizens isn't that they want to do that, but how they are doing it without any sort of due process whatsoever.

I understand the right's reasons for wanting to secure the border and the arguments for and against

deportation. Heck, I even agree with them to a certain extent – the U.S. shouldn't be a haven for the world's criminals. But this column isn't about that, but rather the unconstitutional methods the current administration has used to deport a massive number of people without due process.

Due process is essentially having a hearing, though it is more encompassing than just holding a hearing. Due process gives us a means to ensure the law is being executed correctly. It's how we determine criminals are indeed criminals and not just someone saving they are.
