Twice Sold Treasurers, Inc. of Norton, a unique emporium featuring many types of antiques, collectibles and a bridal registry of fine china and crystal, recently celebrated its fifth anniversary.

Opening on December 1, 1986, the business was first located at 212 S. Kansas in one of Norton's oldest homes near the downtown business district. Wishing to expand the business and gain better visibility, the owners moved the business to the present location at 111 North State in August 1988.

The business is owned by five local women who were all good friends and experienced at conducting garage sales before they became business partners. Each partner brings her own diverse area of interest and expertise to enhance the business.

Owners of the business are Ada Arford, Sara Hartley, Ruth Hartman, Gloria Nelson, and Connie Stromer. Each partner signs up to work one day per week behind the counter. Estelle Hartman is affectionately called their "silent partner" and often works on Saturdays when the others are not available.

The owners all love beautiful things and are infectiously enthusiastic about the items they have for sale. They all share their knowledge of antiques avidly whether small, quirky antiques or elegant dignified objects.

"Beautiful objects that were used and loved in everyday life in the past have become very special to us today," said Hartman. "We have something for everyone, those who have already discovered the warmth that old things bring to their homes, as well as the newcomers to collecting."

"We have learned what sells through osmosis," said Hartman. "Coca Cola signs and memorabilia are currently popular with collectors."

Other items selling well according to Hartman include old Fiesta dishes, old silver, jewelry, post cards, antique Valentines, oak furniture, quilts, old war medals, and biscuits and tobacco tins.

Over 450 area residents have brought in good quality used items they wish to sell through Twice Sold Treasures, Inc. on consignment. These items range from good used clothing, jewelry, antiques, collectibles, and linens.

The consignors may price the item themselves or rely on the owners (consignee) to decide on a suitable price based upon the condition and age of the item and the demand for the item in the marketplace. The owners take 25 percent off the top for their commission on each sale.

In February of 1988, the owners expanded the business to include some new items and a Bridal Registry. Local brides can select their choice of patterns in Gorham stainless

and Noritake crystal and china as well as Homer Laughlin Fiesta dishes.

Other new items are Bella's Secret Garden fragrances, Howard Miller clocks, cotton woven coverlets, and specialty Christmas items.

The owners regularly attend the gift market in Kansas City to seek new products to enhance their current line of merchandise.

Twice Sold Treasures, Inc. also buys estates and has purchased estates from as far away as Topeka and Goodland.

"We will go anywhere to bid on an estate," said Arford who handles the bookkeeping for the business. "We even clean up houses for the realtor when sorting and removing the items we buy for resale."

Twice Sold Treasures, Inc. is listed in the 1991-92 Antique Buyers Guide and many of their customers are from out of town, according to Hartman.

"We draw from a wide area and hopefully our business helps attract new customers to other downtown Norton businesses," said Hartman.

"Many other antique dealers visit our store on a regular basis," said Hartman, "we've made many new friends from a wide area. This venture into the business world has been a valuable learning experience for all of us."

Twice Sold Treasures, Inc. is open six days a week from 10 a.m. until 5 p.m.
