LOOKING BACK

1925 – 100 years ago

If Logan County does not get a real test for oil on the Moffat-Andrews location it will not be they because lacked equipment. The largest oil rig in the state of Kansas sets on the dome two miles east of the Moffat-Andrews Ranch House 26 miles southwest of Oakley and the drill has penetrated over a hundred feet into the shale like gravel with a 20 inch drill. The boilers which furnish the power oil burners and the two big tanks hold a supple sufficient to assure consistent twentyfour hour drilling. The derrick is 96 feet high and the entire rig is built on a larger scale than the ordinary standard rig. It is known as the California DeLuxe. The whole rig is electric lighted from current generated by the team driven dynamo. Water is furnished to the outfit from the spring about three quarters of a mile west of the rig. The water flows from the side of the shale bank into a large supply tank and the draw from where it is pumped up the hill to the right. Three small houses have been built for the workmen. It will take eight men to handle the outfit when the twentyhours shifts of drilling begin. Four men at a time two on the tower and two on the floor of the rig. J.M. Greer and W.M. Anderson are the drilling operators on the job and from their many years experience in all parts of the U.S. Are competent to handle the big rig of which they are justly proud. The project is controlled by Coons and Dunn, two of the big California oil men and is backed by plenty of money. They intend to go at least 4200 feet and the big rig has a capacity of several hundred feet more than that.

Hail and rain swept

through Western Kansas

weekend leaving last paths of destruction through the fields of harvest ripe wheat. Loses in the four counties of Loan, Scott, Sheridan and Gove were estimated at more than one million dollars. Harvest had just got underway when the first storm hit Saturday north and east of Winona and Page City. Losses were estimated at figures varying from 5 to 75 percent in this area. The storm had swept through the Halford community north of Oakley and lashed fields as it moved from the northeast into the Winona area. Late Sunday afternoon hail and storms ripped through Oakley, Sheridan, Gove, and through Scott City and Scott County. Hoxie reported 100 percent loss to all crops in the path of the storm which swept from the northwestern part of the county south to Grainfield and on six miles south into Gove county. The belt of destruction was nearly three miles wide. Α second storm followed in thirty minutes also moving southeast from Hoxie. Losses in the Grainfield area were nearly extimated at 400,000 bushels of wheat with other heavy losses in

Scott City reported hail the size of golf balls fell during a thirty minutes storm followed by an accompanying six hour rain of an estimated 7½ inches which wiped out harvest ripe fields including some irrigated wheat land figuring to produce 50 bushels to the acre. Scott City also reported a small twister at the height of the storm which struck the airport east of town and damaged all six of the plains there.
