If all are intact, they can be saved. Thaw gradually and store at room temperature.

•For commercially canned foods, if seams are broken, they may be contaminated and unsafe to eat. Discard these cans.

•For home-canned foods, discard broken glass containers. If the lid became unsealed and the jar thawed to room temperature, discard these as

well.

If a glass jar became unsealed but is still frozen, it can be safely used immediately or transferred to a new container and stored in the refrigerator or freezer.

With proper preparation and vigilance, you can minimize food loss and keep your household safe. Remember, food safety is crucial - even during emergencies.
