



Scott City Commissioner to shorten the window for shooting fireworks in the city failed by a 3-2 vote during the commission's May 20 meeting.

Kath-Commissioner ryn Salsbury said she researched policies of other cities and counties in the region, including Southeast Kansas and Missouri, and discussed shortening the window for discharging fireworks for the benefit of pets, veterans and other people with PTSD.

Following a discussion on the dates for sales compared to discharge, Salsbury's motion to adjust the city's ordinance to limit the discharge dates for fireworks to July 1-4 with possible provisions in the event of rain the prior weekend, failed with Salsbury and Commissioner Tracy Dancer voting in favor and Mayor Tim VanHoecke and Commissioners Dyllon Olson and Matthew Wells voting against.

Later, Salsbury said she was not sure if a provision could be added to allow discharge the prior weekend if July 2-4 occur on a Tuesday through Thursday.

"I appreciate that people

with it and not make them spend a whole week-plus dealing with it. There's a difference between enjoying fireworks and being really traumatized by them.'

Prior to the vote, Wells said one issue is the city's fireworks display does not take place until July 5, so there would need to be an exception.

"People are going to want to shoot off fireworks on July 5," he said.

VanHoecke asked if there was a second to the motion on the table, which would make the hours for discharge 7 a.m. to midnight on July 3-4, and until 10 p.m. July 1-2. After Dancer seconded the motion, Olson asked if the retail period for sale of fireworks would still be expanded.

"Citizens will be buying and setting off fireworks anyway," he said.

Commissioners received input from Fort Scott Police Chief Jason Pickert, who said the change would be "enforceable."

Commissioners later approved 4-1 a motion by Wells to accept an ordinance with a change on discharge dates to June 27 through July 5, with discharge allowed from 10

fireworks display. Salsbury was the only no vote.

Earlier in the discussion, Salsbury said she recently talked about concerns she has heard for several years regarding people dealing with pets "being very agitated" with fireworks, as well as people with PTSD having issues.

"I was making sure that wasn't a myth, and it looks like according to sources I found through the VA, about 7% of veterans that have had combat issues with explosions have reported they have issues with fireworks," she said.

Salsbury said she wanted to look at closing the window for discharge, "not just for those reasons, but also working parents when it's hard to get kids to sleep. I don't want to be a party pooper, I just thought maybe the week-long-plus is a bit much. And we can scale this back like other towns."

Salsbury said the city of Pittsburg uses the same timeframe as Fort Scott, but is also a city of about 30,000 people. She suggested a three-day window that could even be the weekend prior to the holiday.

The city of Fort Scott Public Works Department has been making improvements to a downtown public parking lot.
