Assessed Valuation and Indebtedness. Assessed Tangible Valuation for Computation of Bonded Debt Limitations for the year 2024 is \$793,721,827. The total general obligation indebtedness of the Issuer as of the Dated Date, including the Bonds being sold, is \$304,435,000; such amount excludes the General Obligation Temporary Notes, Series 202501, dated June 17, 2025, in the principal amount of \$27,885,000 being sold on the same Sale Date as the Bonds. On June 15, 2025, general obligation temporary notes in the aggregate principal amount of \$48,430,000 will be retired out of proceeds of the Bonds and other available funds of the Issuer, which will reduce the outstanding general obligation indebtedness of the Issuer to \$256,005,000.


