# County's Bond delivers tax sale report

Fulfilling an earlier request that had come from the Board of County Commissioners, Jefferson County Treasurer Douglas Bond shared the results of the May 29 tax sale with County Commissioners David Christy, Richard Malm and Doug Walbridge when they met June 16.

Bond told the trio that the sale of tax-delinquent properties generated \$76,025.86 in pre-sale income and \$136,050 in income during the event, for a grand total of \$212,075.86. He went on to report that the county spent \$4,650 in purchasing property it wanted and that its sale-related expenses totaled \$103,606.50.

A one-page handout Bond provided put the profit from the sale at \$108,469.36 (\$212,075.86 minus \$103,606.50) and the profit in cash at \$103,819.36 (\$108,469.36 minus \$4,650).

According to the document, the owners of the tax-delinquent properties owed \$152,400.48 in taxes, \$383,293.65 in special assessments, and \$229.650.21 in interest and fees, for a grand total of \$765,344.34.

It also revealed that the sale recovered 68.1% of the taxes that were owed but only 19.4% of the taxes and special assessments combined and just 13.6 % of the taxes, special assessments, interest and fees combined.

Keyta Kelly with Kelly Law Office LLP, Tonganoxie, handled the legal work associated with the sale and was present when Bond gave his report.

When asked by Christy how the sale had gone, she replied, "Everything went really smoothly." And when Walbridge asked her when the next sale would occur, she responded by saying she was in the process of preparing the necessary petition to be filed with the court but thought the sale could be held within the

next 10 months. According to Kelly, the county is "pretty much caught up" in terms of having brought what reportedly was a backlog of tax-delinquent properties into petitions in a timely manner.

#### Homecare staff pay

In other business, at the request of Health Department Administrator Crystal VanHoutan, R.N., the governing body voted to make what she called "a market rate adjustment" to the pay her homecare registered nurses and management staff are getting. The decision was a unanimous one.

The action was taken after VanHoutan told the commissioners that the county's pay rates were "no longer competitive" and then mentioned the R.N. position her department has been attempting to fill for the past four months but without success. She said no one has even applied for the job.

VanHoutan informed the commissioners that she would be pulling a full-time R.N. position from her budget request for 2026 and said the move would save the county approximately \$58,000.

In a related matter, later in

the meeting the board passed Resolution 2025-020 on a 3-0 vote. This resolution increases VanHoutan's biweekly salary from \$3,577.68 to \$3,720.79, a difference of \$143.11.

The raise took effect June 15.

#### Comprehensive plan

Community Development Director Stephan Metzger informed the board that the first draft of the new Comprehensive Plan for the county would be completed soon. He then proceeded to discuss one of the proposed changes to the existing plan, a change that would affect the owners of parcels of land covering 20 acres or more.

According to Metzger, if someone owned an 80-acre parcel, for example, he or she would be able to divide that parcel three times through a single so-called "ag lot split," turning it into four 20-acre parcels.

Now, however, he related, the owner has to chop an 80acre parcel into two 40-acre parcels and then wait before separately cutting up each of these parcels into two 20-acre parcels.

Metzger said the change, if ultimately approved, wouldn't allow the owner of a parcel of fewer than 20 acres to break that parcel up into smaller parAs previously reported in the paper, Marvin Planning Consultants Inc., David City, Neb., is putting together the new Comprehensive Plan and revising the current zoning regulations as needed.

#### Sewer line break

It was the consensus of the board that Jefferson County Rural Water District No. 11, which oversees the operation of Jefferson County Rural Sewer District No. 7, be permitted to dump four loads of dirt, rock, and ceramic tile at the 11-acre site where the lagoon for the Wind-N-Wave subdivision used to be located. This site is owned by the county.

The decision was made after Tod Edmonds, the chairman of the JCRWD No. 11 board, appeared before the commissioners to let them know about a "sewer line break" that had occurred in Lake Ridge Estates. He said the ground would need to be dug up for a distance of 250 feet to deal with the problem and also said some asphalt from a road would probably have to be removed, too.

Edmonds wasn't sure if the line had actually broken or had simply collapsed.

Edmonds told the commissioners he hoped the excavation work could begin sometime that

According to Edmonds, letting JCRWD No. 11 dump dirt, rock and tile at the Wind-N-Wave subdivision site will enable it to save roughly \$3,000 in possible hauling fees.

VanHoutan read aloud a detailed report that had been prepared for the meeting by Edmonds, a report that covered the operation of JCRSD No. 7 last year and through the first five and a half months of this year. Information from this report will be published in a future issue of the paper.

JCRSD No. 7 serves Lake Ridge Estates and the Wind-N-Wave subdivision.

#### Drug Take Back Day

The Health Department administrator also reported that four individuals had taken advantage of the opportunity to get rid of unwanted medications on Drug Take Back Day, which was held two days earlier at the Law Enforcement Center in Oskaloosa. She said a "significant amount of medications" were turned in by these individuals.

The Health Department will be leaving it up to the Sheriff's Office to properly dispose of the medications.

As previously reported in the paper, citizens can get rid of both unwanted medications and illegal drugs by placing them in the Safe Drug Drop (aka the "amnesty box") on the north side Heston reported that she and Deputy Register of Deeds Karen Weishaar had assisted the Treasurer's Office with the tax sale and then gave the commissioners an update on the use of some new Laredo Connect software by her office in April and May.

#### **COOP** building

Micah Stegall, the owner of the building at 501 Delaware Street in Oskaloosa, appeared before the commissioners to inform them that the remodeling of the structure would be finished in two days and subsequently invited them to drop by at their convenience to have a look-see at the project.

The one-story building on the southeast corner of Delaware and Washington streets will house The COOP (COOP being an acronym for Community of Oskaloosa Outreach Program).

Stegall, who attends Living Water Evangelical Free Church, rural Oskaloosa, told Christy, Malm and Walbridge that The COOP would be "just a place where they (youth) can go" to experience wholesome fellowship with others.

When County Counselor Josh Ney asked Stegall why The COOP was chosen as the name for what amounts to a ministry, he said the name was inspired by a word that had been painted



ARTICLE 2 AND ARTICLE 3. WHEREAS, the City Council of the City of Oskaloosa, Jefferson County, Kansas has received a complaint from the city enforcement officer that there exists, on the premises of 814 Delaware Street, Oskaloosa, Kansas (the "Property"), a nuisance comprised of trash, junk, refuse, household goods, unsightly materials, motor vehicle parts and other debris all in violation of Section 8-308 of the City Code; and

WHEREAS, the City Council has also received a complaint from the city enforcement officer that there exists, on the premises of 814 Delaware Street, Oskaloosa, Kansas (the "Property"), a nuisance comprised of weeds, yard waste and other natural debris in violation of Section 8-201 of the City

Code; and WHEREAS, the city enforcement officer, on or about January 2, 2025 gave notice to the property owner that the violation existed and must be abated, and further that the City Attorney, via certified letter, gave a further Order of Violation to the property owner on May 6, 2025, with the same

being received and signed for on May 14, 2025; and WHEREAS, these notices, being sent to Robert and Mattithyah Bergersen, informing them of the ongoing violations and giving the owners ten days to abate the nuisances and/or to request a hearing in front of the

city council; and

WHEREAS, the owners have not abated the conditions on the property, have not requested a hearing or otherwise addressed the matter and the nuisances

remain: and

WHEREAS, the City Council deems it advisable to proceed to abate the nuisances on the property in accordance with the City Code.

BE IT RESOLVED BY THE CITY COUNCIL, CITY OF OSKALOOSA, JEFFERSON

COUNTY, KAŃSAS: That pursuant to Ordinance No. 2018-02, Chapter VIII, Article 2, Section 8-208 the City Council hereby finds that the above conditions are in violation of the City Code and the owner shall have Twenty (20) days from the passage of this Resolution to abate the nuisance conditions. Should the nuisances not be abated the City of Oskaloosa by its agents or officers is hereby authorized to abate the condition causing the violation and remove the nuisance from the property pursuant to 8-208.

BE IT FURTHER RE-SOLVED:

That should it be necessary to abate these conditions, any and all costs incurred by the City of Oskaloosa, Kansas, including attorneys' fees, shall be charged against the above-described property as provided in Ordinance No. 2018-02, Chapter VIII, Article 2, Section 8-210 and 8-314, and the City Clerk shall, at the time of certifying other taxes to the County Clerk, certify the costs of cleanup. The County Clerk shall extend the same on the tax roll and it shall be collected by the County Treasurer and paid to the City of Oskaloosa as other City taxes are collected and paid.
