\$47,000 in its Opioid Fund.

In other business during the board's weekly meeting, Christy, Malm, and Walbridge agreed to sign an official notice stating that the county intends to exceed its revenue neutral rate for 2026 in coming up with a budget for next year and then scheduled the required public hearing on the proposed adoption of a mill levy above the

The county's RNR for next year, which was calculated by the Office of the County Clerk, is 64.551 mills. But to fund the budget currently being proposed by the commissioners, the property tax rate will have to be set .998 of a mill higher at 65.549 mills.

The county's auditor, Sean Gordon with Gordon CPA LLC, Lawrence, was on hand for the relatively brief discussion that preceded the board's decision to go with a mill levy that surpasses the RNR. So were Community Development Director Stephan Metzger and County Counselor Josh Ney.

The board set the RNR hearing for Monday, Sept. 8, at 1 p.m. The hearing will be held at Oskaloosa City Hall, 212 W. Washington, to accommodate a possible turnout well beyond the capacity of the room where the commissioners usually meet.

More information about the proposed budget for next year will appear in a future issue of the paper.

After declaring himself to be "very much pro-farmer," Public Works Director Ben Domann told the commissioners that "very many" farmers in the county have been planting crops within the county's right of way for roads. He proceeded to relate that he fully understood why farmers, faced with higher input costs these days, would want to put seeds in as much ground as possible, but he said some of the plants that are now coming up are interfering with the visibility of stop signs, curve signs, and other important markers. He then remarked that because of safety reasons, he has no choice but to mow down these plants.

"Please obey the right of way with crops," Domann indirectly pleaded with farmers in using the paper, through this story, to send a message to them he hopes they will take to heart.

Subject to Domann's approval of the proposed project on site the next day, the board voted unanimously to issue a right-of-way permit to Jefferson County Rural Water District No. 2, clearing the way for the water district to make a cut across Nemaha Road 30 feet in length to install a water line. If OK'd by the Public Works director, the road will be dug up as needed at 3422 Nemaha Road.

Bryan Blanck of Lawrence, who recently purchased five lots at Westshore Estates from the Jefferson County Land Bank, appeared before the board to report that he had looked into the cost of having (Continued from page 1)

these lots replatted as a single Lot 77, Lot 86, Lot 87, Lot 88, lot (this was one of two conditions attached to the sale) and had learned that the expense would amount to an estimated \$4,000. He also said the surveyors he had contacted expressed little interest in tackling the project.

Blanck told the commissioners that he couldn't afford \$4,000 for replatting and didn't want to spend the time and money the move would require on his part. He then wondered if perhaps the board could place a restriction on the deed for the lots requiring that they be sold

Ney told the commissioners that the same basic issue had emerged during a county tax sale and went on to remark, "I wouldn't want to try to add complexity to it (the existing situation).'

Metzger told the commissioners that putting restrictions on a deed wasn't as strong as a replatting in terms of being able to guarantee that a piece of property will be transferred from one party to another in the intended configuration.

He then warned the trio, saying "If we can't sell them (the lots) here, we might not be able to sell them ever.

Blanck said that if indeed he is stuck with the lots, he is planning to do something with them within the next couple of months.

Metzger indicated to the board that he was prepared to furnish it with a resolution designed to clarify the situation involving the lots. He then promised to produce that resolution the following week.

"Let us (county officials) look at it (the problem) and come up with a solution," Walbridge told Blanck.

On a 3-0 vote, the board approved the proposed transfer of 15 lots from the county to the Land Bank. Those lots were Lot 72, Lot 73, Lot 74, Lot 76,

Lot 89, and Lot 90 in Block S of Lake Shore Estates, Lot 271 in Unit I of Lakewood Hills. Lot 176 and Lot 177 in the Parkwoods section of Lakeside Village, Lot 31 in Block W of Lake Ridge Estates, and Lot 1 in Block C of the Indian Ridge subdivision.

On a separate 3-0 vote, the board authorized Christy to sign three Quit Claim deeds on behalf of the governing body. The deeds covered the conveyance of Lots 72-74, Lots 76 and 77, and Lots 86-90 in Block S of Lake Shore Estates, Lot 271 in Unit I of Lakewood Hills, Lots 176 and 177 in the Parkwoods section of Lakeside Village, Lot 31 in Block W of Lake Ridge Estates, and Lot 1 in Block C of the Indian Ridge subdivision.

The board voted unanimously to allow Christy to sign on behalf of the governing body a Quit Claim deed transferring a tract of land near the entrance to Lakeside Village from the Land Bank to Asa Collier of

Voting 3-0, the board OK'd the proposed issuance of new county credit cards to four employees of the Sheriff's Office, Emily Hamm, Viola "Dee" McHardie, Jordan Pantle, and Philip Steinlage.

Voting 3-0 again, the board authorized Christy to sign the second part of the paperwork for a Shared Leave request that had been approved a week
