#### RESOLUTION NO. 2025-07

**A RESOLUTION FIXING A TIME AND PLACE AND PROVIDING FOR NOTICE OF A HEARING BEFORE THE GOVERNING BODY OF THE CITY OF FRONTENAC, KANSAS, AT WHICH THE OWNERS, THEIR AGENTS, LIENHOLDERS OF RECORD AND OCCUPANTS OF THE STRUCTURE LOCATED AT 403 N. CRAWFORD STREET MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURE SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS AN UNSAFE OR DANGEROUS STRUCTURE.**

**WHEREAS**, the City Administrator has filed with the Governing Body a written statement that the structure located on the property commonly known as:

PROPERTY ADDRESS: 403 N. Crawford Street

Owned by: David & Carol Gee, 202 S. Crawford St., Frontenac, KS 66763 is unsafe, dangerous, and unfit for human use or habitation due to conditions described in Chapter 8, Article 3 of the Code of the City of Frontenac, Kansas, and pursuant to K.S.A. 12-1750 et seq.; and

**WHEREAS**, the Governing Body finds it necessary to set a time and place for a public hearing at which the owner(s), their agents, lienholders of record, and occupants may appear and show cause why the structure should not be condemned and ordered repaired or demolished.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF FRONTENAC, KANSAS:**

1. That a hearing will be held before the Governing Body at Frontenac City Hall, 313 East McKay Street, Frontenac, Kansas, on the July 9, 2025 at 6:30 p.m., at which the owner(s), their agents, lienholders of record, and occupants of the above-described property may appear and show cause why the structure should not be condemned and ordered repaired or demolished.

2. That the City Clerk shall cause this Resolution to be published once each week for two consecutive weeks in the official city newspaper and shall mail a copy of this Resolution to the owner(s), the owner's agent(s), any lienholders of record, and occupant(s) of the structure, at their last known addresses, by certified mail within three (3) days of the first publication.

3. That this Resolution shall take effect and be in force from and after its adoption and publication as provided by law.

#### ORDINANCE NO. 2025-07 Summary

On May 14th, 2025, the governing body of the City of Frontenac, Kansas, adopted Ordinance No. 2025-07, entitled:

**AN ORDINANCE REGULATING DANGEROUS, ABANDONED, OR NUISANCE MOBILE HOMES OR TRAILERS NOT PERMANENTLY AFFIXED TO REAL PROPERTY, PROVIDING FOR NOTICE, ABETEMENT, AND PENALTIES, AND ADDING ARTICLE 6 TO CHAPTER 8 OF THE CITY CODE.**

The purpose of this Ordinance comes from a growing concern related to the presence of abandoned, dilapidated, and unsecured mobile homes and trailers in the city limits. The Ordinance establishes Article 6 of Chapter 8 in the City Code and sets forth comprehensive regulations for identifying, abating, and removing mobile homes that constitute a public nuisance. A complete copy of this ordinance may be obtained or viewed free of charge at www.frontenacks.net or at the office of the City Clerk, City Hall, 313 E. McKay Street, Frontenac, KS. A reproduction of the original ordinance is available for a minimum of one week following the summary publication in the newspaper.
