because of the Department of Revenue's requirement that each printer be outfitted with three trays, the one the printer comes with and two others.

In other business during the board's weekly meeting, the governing body accepted the apparent low bid on replacing the deteriorating floor in the building housing the Auxiliary Services Office at the county shop just east of Oskaloosa.

That bid was supplied by Midwest Flooring, Perry, and was in

the amount of \$5,048.53. Midwest Flooring's bid was one of three bids Public Works Director Ben Domann was able to secure from area businesses. The other two were submitted by Seifert's Flooring Inc., rural Tonganoxie, and Murray's Flooring LLC, Topeka.

Seifert's Flooring priced the job at \$5,123.60, while Murray's Flooring wanted \$8,008.39 for the work that would be involved.

There are three offices and two hallways in the Auxiliary Services Office.

Domann told Christy and Walbridge that the funds needed for the project could be found in his department's budget for the

The board voted to spend \$18,868.75 to obtain an extended warranty for the John Deere motor grader the county decided to hang on to, rather than trade in, several months ago.

The warranty from EPG Global LLC, Dover, Del., will essentially buy the Road and Bridge Department an additional 24 months or 2,000 hours of "used" coverage on the machine, a 672G, for its powertrain and hydraulics system.

"Used" coverage will cover up to 50 percent of the value of the machine, according to an email Domann got from Jeremy Geiger with Murphy Tractor & Equipment Co., Topeka, the dealership that arranged the warranty.

Domann reported that Dondlinger and Sons Construction Co. Inc., Wichita, had begun demolishing the bridge along McCall Drive north of Oskaloosa a week earlier and had completed the work in anticipation of building a replacement bridge. He said the new bridge would be 120 feet long, twice as long as the bridge that had been there. "Everything's going as planned," he commented.

According to the Public Works director, the construction site will be "out of commission" for three

Domann told Christy and Walbridge that he had worked out an arrangement with Dondlinger and Sons Construction Co. whereby the county will get 1,000 cubic yards of dirt at no charge from the company, which reportedly is willing to deliver the dirt. The dirt will be coming from the construction site, which, according to him, will be the scene of a fair amount of excavation work as crews create the space needed for the construction of the longer bridge.

It was the consensus of the board that further consideration of the possible submission of an application for a Safe Streets and Roads for All grant be tabled for a week to give Commissioner Richard Malm a chance to share his thoughts on the matter before a decision is made.

Christy and Walbridge arrived at a consensus after they had heard from Brandy Sutherland with Blue Valley Consultants LLC, Riley. She told the duo that the Oskaloosa City Council and the McLouth City Council have voted in favor of participating in the grant under the county's "umbrella," so to speak, and that the City of Meriden is supportive of the application, but that she was still waiting to hear from the City of Ozawkie, the City of Winchester and the City

of Perry The City of Valley Falls and the City of Nortonville reportedly have already gotten SS4A grants and have completed the plans associated with these grants.

According to Sutherland, the county is up against a June 2 deadline to apply for a Safe Streets and Roads for All grant.

As previously reported in the paper, the Federal Highway Administration will provide 80 percent of the money for a grant, and Kansas Bipartisan Infrastructure Law funds will account for 95 percent of the 20 percent local match, leaving it up to a county and possibly one or more of its cities to supply the rest.

Sutherland is of the feeling that a \$1 million grant would be appropriate for Jefferson County.

At the request of Emergency Manager Keith Jeffers, the board passed Resolution 2025-016, a resolution encompassing a Proclamation of a State of Local Disaster Emergency for Jefferson County."

The action was taken after Jeffers had made Christy and Walbridge aware of the weather forecast for northeast Kansas for that evening and the next three days. According to him, the National Weather Service was predicting for that evening the possibility of supercells developing, wind gusts of 60 to 70 miles per hour, and baseball-size hail, and for the next three days, "more neavy rain.'

He said the NWS had identified the time period from 7 to 11 p.m. as being the "highest risk window" for severe weather.

The resolution said the board "finds that certain conditions caused, or eminently threaten to cause widespread or severe damage, injury or loss of life or property in disaster proportion" in Jefferson County.

The resolution was scheduled to expire in seven days unless the board renewed it this past Monday or terminated it before

Pre-vote, Jeffers called the proposed passage of the resolution "a pre-emptive move."

In response to an inquiry from the board, Bond said the next sale of tax-delinquent properties by the county would take place May 29, and he confirmed that the sale would include a certain piece of property that reportedly has a communications tower on

That property, which the county apparently has an interest in, is located along 62nd Street, east of US-59.

After recessing the meeting to allow the commissioners to meet as the directors of the Jefferson County Land Bank, through separate votes, Christy and Walbridge favorably received four offers on seven county-owned lots, including one that represented the best offer on two lots in Mer-

James Trainor and Diane Davis, 200 E. Water, Meriden, outbid Marc Woods and Laci Heller, 115 Cottonwood Court, Ozawkie, for the two lots in Meriden, Lots 3 and 5 in Block 4 of the Original

Trainor and Davis were willing to part with \$5,400 altogether, \$2,700 per lot, to gain control of the lots. They plan to erect a garage there.

Heller and Woods were ready to shell out a total of \$5,200, \$2,600 per lot, to get the lots. They had been hoping to build a single-family dwelling or a duplex there.

Steven Seifert of Overbrook ended up with Lots 485, 486 and 489 in the Hickory Hills section of Lakeside Village. He was up to handing over \$500, the minimum acceptable bid, for each of the lots, for a grand total of \$1,500.

Pervis and Janice Ewer, 9254 Valley View Drive, Ozawkie, came away with Lot 15 in Block W of Lake Shore Estates. Their bid was for an even \$500.

Thomas and Patricia Tripp, 8057 Westshore Court, Meriden, locked up Lot 37 in Block M of Lake Ridge Estates. They, too, had a bid right at \$500.

The recess to accommodate the business of the Land Bank asted about 25 minutes.

The presentation of the bids was handled by Community Development Director Stephan Metzger and was preceded by a brief overview of land use patterns in Jefferson County. According to him, based on survey results, residents of the county are in favor of the preservation of land classified as agricultural

Metzger reported that he would be presenting a land use proposal to the Planning Commission that evening and said he would have more feedback for the board to consider in two weeks.

With Metzger still present. County Counselor-designate Jonathan Ehrlich told Christy and Walbridge that the County Attorney's Office was working with the Community Development director to see to it that alleged violations of the county's zoning regulations are prosecuted in Jefferson County District Court.

Resolution 2025-015, a resolution reappointing County Appraiser Janet Allen to a four-year term in office, was OK'd by the

On separate votes, the board also passed four resolutions authorizing the transfer of 2024 county funds, Resolution 2025-010, Resolution 2025-011, Resolution 2025-013 and Resolution 2025-014.

Resolution 2025-010 clears the way for the county to withdraw a total of \$1,289,650 from various funds and departments and add it to the Equipment Reserve Fund. Of that amount, \$329,000 will come from the General Fund, \$900,000 from the Road and Bridge Department, and \$60,650 from Auxiliary Ser-

The General Fund's contribution to the Equipment Reserve Fund will consist of \$30,000 from the County Clerk's Office. \$60,000 from the County Treasurer's Office, \$105,000 from the Courthouse General Fund, \$25,000 from the Community Development Office, \$25,000 from the Emergency Management Department, \$35,000 from the Geographic Information Systems/Information Technology Department, \$37,000 from Jefferson County District Court, \$5,000 from the Register of Deeds Office, and \$7,000 from the 911 Communications Fund.

Resolution 2025-011 will let the county move a total of \$245,675 from various funds and departments to the Capital Improvement Fund. Of that amount, \$15,000 will come from the Ambulance Fund, \$150,000 from the Law Enforcement Fund, \$60,675 from Auxiliary Services, and \$20,000 from the County Clerk's Office.

Resolution 2025-013 will allow the county to pull \$100,000 from the Ambulance Fund and put the money in the Ambulance Capital Outlay Fund.

Resolution 2025-014 will enable the county to take \$60,675 from Auxiliary Services and give it to the Noxious Weed Capital

Outlay Fund. The board approved the proposed issuance of a cereal malt beverage license for 2025 to Grantville C Store LLC, 3522 US-24 Highway, Grantville, and authorized Christy to sign the necessary paperwork on behalf of the governing body. The move was necessitated by the recent

sale of the convenience store,

which had been known as Joe's

Kwik Mart.

The board voted to table for the time being further consideration of the budget request for 2026 that had come in from Cottonwood Inc., Lawrence. Cottonwood, which provides services to adults with disabilities, is asking the county to back the agency's work with \$75,000 next year.

The board OK'd the proposed issuance of a new county credit card to Bond and authorized Christy to sign the necessary paperwork on behalf of the governing body.

Executive Session At the request of Chris Sch-

meissner, the county's Geographic Information Systems/ Information Technology director, the commissioners met privately with him for 10 minutes for the stated purpose of discussing personnel matters relating to nonelected personnel. "Employee recruitment and transition" was identified as being the subject that was to be discussed. When the meeting reopened to the public, Christy announced that no binding action had been taken behind closed doors.
