Even without a successful title defense, Meyer said the season was very successful, ending with a 21-5 record.

"We played arguably, one of the toughests schedules in the state, playing teams like Frontenac (3A state champion), Silver Lake (3A state runner up), McPherson (4A state champion), seaman and Shawnee Heights. We faced adversaries by losing two key starters to injuries (Hardenburger and Arabell Razzano). We had girls step up by playing out of their normal position and handling the adversity. We pride ourselves in having the "next girl up" mentality."

Meyer added, the team made its fifth trip to state in an extremely tough 4A bracket. "This team has continued to raise the bar."

Next year look bright for the Lady Raiders, even though they lose three seniors who have "made an unbelievable impact on our program".

Departing will be Hardenburger, Razzano and Kyra Olberding, all of whom Meyer said has left an "unbelievable legacy" on the program. "They have an overall record of 89-12, back-to-back state champions and a third place finish," he said. "Above that, their leadership and personalities will be greatly missed."

Wamego will have large core of contributing players returning next season. Alana McCarthy, Landri Adams, Rylee Stanley, Tulsa Schultz, Averie Hall, Morgyn Evans and Emilly Crocker will be returning starters. They also return some key role players as well Lexi Cook, Kylie Bosch and Evyn Folck.

"We look to have another strong season in 2026. Meyer concluded.

In the following game, Rock Creek fell behind 4-0 by the bottom of the third inning. However, the Mustangs had an opportunity in the top of the fourth to catch up. Rock Creek ended the game with five hits and 11 strikeouts.

Brynna Zoeller took the loss for Rock Creek, allowing four runs (three earned) on eight hits with two strikeouts.

"Eudora came into this game averaging 11 runs scored a game, and in their only loss they were held to three runs," said RCHS Coach Jeri Brummett. "We held them to four, which is a compliment to our defense and pitching.

"To get to this tournament is a feat in and of itself," she continued, "so I'm beyond proud of that accomplishment. Each team of eight in the tournament present their own unique challenges. Three of our NCKL teams were in this year's tournament and several of the same teams that were in the 2024 state tournament."

Brummett had kudos to her seniors for their final

"(It was) their heart, grit and perseverance that got us to this place again," she said. "Kudos to the entire 'Team 29'," it takes the starters, the non-starters, junior varsity and all of our team to continue to push one another, support one another and belove in something bigger than themselves. This is our program, this is our goal, and we didn't get to the championship, but we certainly continue to knock at the door."

league champs and regional champs. Individual accomplishments included sophomore Brock Lubbers, who earned First-Team All-State and First-Team All-NCKL honors while tying a school record with nine wins, striking out a record-setting 92 batters, and finishing with a stellar 0.770 ERA over 63.2 innings; senior Drew Becker, a First-Team All-State DH and First-Team All-NCKL utility player, recorded a .312 batting average with 14 RBIs and five doubles, ranking third all-time in RBIs (72) and ninth in career hits (72), while becoming Rock Creek's all-time leader in hit-by-pitches with a staggering 49; freshman outfielder Jordy Scott earned First-Team All-State and First-Team All-NCKL recognition with a .393 batting average, six doubles, three triples, a home run, and 21 RBIs, ranking 12th in single-season hits (35); senior infielder Donavan Debita, a First-Team All-

NCKL selection, led the team in doubles (8) and runs scored (29) while hitting .330, placing ninth all-time in career doubles (17) and securing top-12 single-season marks in the category; junior infielder Peter Martinie, also First-Team All-NCKL, contributed a .282 batting average and a team-leading seven sacrifices; senior pitcher Cooper Sieben, an Honorable Mention All-NCKL honoree, posted a 2.69 ERA over 36.1 innings, tied the school record with nine single-season wins in 2024, ranked 10th alltime in career strikeouts, and placed sixth in career wins; and senior pitcher Ryker Zoeller, a First-Team All-NCKL selection, became Rock Creek's alltime leader in career wins (24) and strikeouts (183), finishing the season with an 8-3 record, a 1.01 ERA, and 73 strikeouts over 69.1 innings, including a complete-game shutout in the regional semifinal against Eudora and a dominant performance in the 4A State semifinal victory over top-seeded McPherson.
