WHS forensics takes on Nationals

The Wamego High School Forensics Team traveled May 22 to Chicago to compete in the National Catholic Forensic League tournament.

The team, headed by Coaches Jennifer Topliff and Jennifer Nider, consisted of Maddox Topliff, Kalli Miles, Cloe Learned, Liberty Sharpe, Shelby Coleman, Breckin Musyoki, Hollie Schliffke, and Lily Hansen.

Prior to competition, the team explored Chicago, taking in the cultural and educational opportunities the city has to offer. This included a crime tour of Chicago's many historical sights, a trip to the nationally acclaimed Field Museum, an afternoon of fun at Navy Pier, an architecture tour taken by boat to see the city's incredible buildings, and of course a trip to Millennium Park to see The Bean.

Once preliminary competition began on May 24, students performed four times throughout the day, being scored each time. That night, it was released that Hollie Schliffke broke into octo-finals, meaning another day of competition for her. She ended up scoring 41st in the Nation, an incredible feat.

"Forensics is an amazing opportunity and I get to talk about topics I am very passionate about," Schliffke said.

The team overall competed well with Topliff saying of this year's Nationals Team, "I'm proud of our whole team from how they performed and how they represented Wamego in Chicago."

As Wamego Forensics wraps up the 2025 season, sights are already set on next year's competition. "Preparation for next season began before we even left for nationals and that speaks to the caliber of students we have," Topliff said.

St. Marys considers nuisance of uncut grass

At the June 3 regular meeting, Kevin Cowan, with the law firm Gilmore Bell, spoke to the St. Marys City Commission about the plan to sell sewer bonds for the Lakeview lift station. "The authorization of the project and the bonds is pretty straightforward," Cowan said. He explained that it would require authorizing the bonds, a sale resolution, and an ordinance to "approve the details of the bonds." Cowan discussed the pros and cons of general obligation issue bonds or utility revenue bonds: while general obligation bonds would be simpler, they have a lower interest rate.

"My concern was we wouldn't be able to use funds from the sewer fund," said City Commissioner Matt Childs. "But apparently we don't have to pay it from the general fund." Childs asked Cowan about getting a financial advisor. "If this were a \$10 million issue, I'd say get a financial advisor as soon as possible," said Cowan. As the project will only be around \$2 million, Cowan simply recommended a financial advisor. Cowan also pointed out that, since the statutes regarding the project are rather old, there might be limitations on the number of bonds that could be issued.

The Commission continued the discussion of the revision of the nuisance ordinance from the previous

Chandler to serve two lifetime terms after Westmoreland sentencing

WESTMORELAND — Dana Chandler received two life sentences on Tuesday with no parole eligibility for 25 years, in yet another drawn-out court proceeding.

Shawnee County judge Cheryl Rios ordered Chandler's terms be served consecutively, meaning parole eligibility actually won't come until Chandler serves 50 years. Her prior incarceration of about 10 years, resulting from her initial conviction of the crimes, will be credited to the new sentence.

Columbian to improve lighting

On Tuesday, June 3 the Wamego City Commissioners considered a request from the Columbian Theatre Executive Director Clint Stueve to allow the theatre to upgrade their lighting system. Stueve explained that the lights currently used to illuminate the stage are 30 years old and outdated. In fact, they recently went out during a performance forcing the actors to make do in the dark. The Columbian is having to rely on second hand replacement parts to fix the system and is hoping to completely replace it with a newer LED lighting rig. Stueve was before the Commissioners requesting permission to pursue the new lights and the installation process. The lighting system itself would
