# NO. 1818 On June 3, 2025, the governing

body of the City of Wamego, Kansas passed an ordinance entitled: AN ORDINANCE AU-THORIZING AND PROVIDING FOR THE ISSUANCE OF PRIN-CIPAL AMOUNT OF ELECTRIC UTILITY SYSTEM REVENUE BONDS, SERIES 2025, OF THE CITY OF WAMEGO, KANSAS; MAKING CERTAIN COVE-NANTS AND AGREEMENTS TO PROVIDE FOR THE PAYMENT AND SECURITY THEREOF AND AUTHORIZING CERTAIN OTHER DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH.


