a standing position before it drops flat on the hill when the race begins; riders then drive over the top of the gate to start each race.

Roughly \$5,000 was spent on the application of a specialized glue that is meant to hold the track in place. Someone got on the track with a dirt bike after recent heavy rainfall so the glued surface got messed up.

Park City BMX vice said the glue helps make the track safer and more fun for the riders.

'The glue is designed to maintain the surface to keep it nice and smooth for the riders," said Kieffer. "But when the track is wet, it becomes more malleable. And then when we have recreational vehicles entering illegally, it causes these deep ruts. Technically, it is trespassing, but they are issue. Park City BMX has not really prohibited from going back there by any physical barriers. So tonight, we are going to be dragging the track and restarting with our surface; and the \$7

now lost. We have a very significant race coming up in September. We are going to host a state finals based on our success over the last couple of years. A lot of hours of track volunteer time is going to be needed to get our track back in working order for those big races.'

Improper use of the track has been an ongoing asked people to stay off the track when its wet and to stop using motorized vehicles on it, but efforts to prevent damage have failed. "We really need assistance in being able to prevent trespassing," said Kieffer. "We've talked about how to go about this," said Park City BMX track operator and president Jamie Johnson. "I know it's part of the park and everybody wants it to be accessible, but we've talked about it off-and-on. That's \$7,000 that we put into the surface and all it takes is one bike or scooter or one dirt bik the past to get it ready for go out there and break up

the surface of the glue; and then all the water gets under the glue and destroys all of the glue. We want to have a great facility that people want to come to and it's hard to keep putting all of our money into it and just having it destroyed." Council members

George Glover and Linda Westhafer both expressed support for helping the group look at fencing the track. Glover praised the group for its hard work maintaining the track and Westhafer noted that the events hosted by Park City BMX bring a lot o people to the city.

only coming in one entrance and cars coming in and out. People are just gonna have to be patient with the process and just know that it's the old adage, to make an omelet, you've got to break some eggs."

High school Principal Eric Flaton said the school will follow the same parking lot procedures it did when work started in the spring.

"If we all follow the plan, it helps keep everyone safe," Flaton said. "Returning students and parents used the same protocols last year, and while it may take a little longer, the parking

lot is typically clear by 3:05. We're simply asking for 10 minutes of patience to ensure a safe and efficient dismissal."

Flaton reminded parents and students that:

•There is no parent entrance on the west side after school. This area is for buses only.

•Parents must enter from the south for student pick-up.

•There is no parent pick-up north of the roundabout.

The classroom additions — a wing on the northwest part of the school and a classroom on the northeast corner - as well as the standalone supplemental learning center on the south side of the school should be open by the

2026-27 school year.

Flaton said the new classroom to support the school's career and technical education program will expand opportunities for students, while the 18-classroom addition will accommodate the rising student population.

"While we know this could change based on resources, we hope to focus on expanding engineering, aeronautics and our graphic design programs," Flaton said. "Currently, every classroom in our building is in use, and we are operating at full capacity. As enrollment projections continue to rise, the new wing positions us to meet

future growth while continuing to provide high-quality learning experiences for our students."

Flaton said the supplemental learning center will house the district's alternative education programs, including The Learning Center and Next Steps Academy, which are currently in a building on South Meridian.

Meanwhile, a classroom addition at the intermediate school will open this fall.

With the addition of new classrooms, we are now able to move staff members out of shared spaces and into their own rooms," intermediate

school Principal Heath Elliott said. "We will keep two of the six new classrooms open this year to use as flexible student workspaces, such as quiet, separate settings for assessments and other support services. Last school year, we had no open classrooms, which made it challenging to find dedicated workspaces for students and staff when needed."

The intermediate school is for fourth- and fifth-graders. The addition is on the west side of the building in the 700 block of North Meridian.

"As enrollment continues to rise, we'll be able to add sections (when needed) more comfort-

ably without being limited by classroom space," Elliott said.

The middle school restrooms are in the school's B Hall, which previously did not have any restroom facilities.

Work is progressing on the new elementary school near Fifth and Seneca. It also is expected to open for the 2026-27 school year.

The projects are part of a \$58.9 million bond issue that voters approved in 2024.
