Lions beat Salina Central

The Goddard Lions girls soccer team packed in three games last week, beating Salina Central on Monday before falling to Maize and Andover Central.

The score on Monday, April 28, at Salina Central was 3-1. Bailey Hess scored two goals and Chloe Mott one. Nikki Phan, Brinley Hedden and Maddyn Snyder had assists.

"We went down 1-0 to start the game and had to climb our way back," Lions head coach Ali Heithoff said. "After that, Bailey Hess got us started with a goal in the first half. ... There was a big focus on build-up play, out of our back and into the attacking third."

On April 29, with five starters out of action, the Lions lost 8-0 at Maize.

"In games like that where we're mismatched against our opponent, I try to shift the objectives, not just focusing on the final result, but what are the little things we can accomplish throughout the game to be successful?" Heithoff said. "I had a handful of JV girls who started that game and had never played varsity, so it was a

Swimmers take part in season's biggest meet

The Campus Colts and Eisenhower and Goddard Tigers took part in the Maize invitational last week, a two-day meet on Friday and Saturday that featured 26 teams.

The Colts fought to get into the top 10, finishing 10th with 105 points. Hays beat Campus by a half-point, and the Colts were 1 point ahead of Hutchinson and 4 points ahead of Bishop Carroll. The new combined Eisenhower and Goddard did not score any points, one of three teams to do so against a very tough field. The top 16 finishers in each event scored points.

Campus did its best in Friday's diving, with all three participants placing in the top 16. State qualifier Joslyn Cox had a strong effort, placing fourth. Paiton Strain and Alexis Evans finished ninth and 11th.

Kimberlyn Grim placed well in a pair of events. She won the 200-yard freestyle on Saturday in 1:59.18, the only time under two minutes. She later took second in the 100 backstroke.

The Colts' other placers were Zoey Skiles of Clearwater in the 500 freestyle, and up-and-coming sophomore Carrigan Welch in the 100 breaststroke. Both finished 15th. Campus also placed in all three relays. The Colts' best finish was 10th place in the 200 freestyle relay.

Both teams are off this week. The league meets will be May 16-17. Campus will compete in the Ark Valley Chisholm Trail League Div. I meet in Salina, while Eisenhower and Goddard will be at the Div. II meet in Maize.

THE CITY OF GODDARD, KANSAS ORDINANCE NO. 997

AN ORDINANCE AMENDING THE CITY OF GODDARD ZONING REGULATIONS BY AMENDING THE REQUIRE-MENTS FOR SITE PLANS UNDER ARTICLE 11: WHERE-AS, notice of a April 14, 2025, Goddard Planning Commission public hearing on changing the site plan criteria was published in the official city newspaper on March 20, 2024. WHEREAS, the Goddard Planning Commission conducted a public hearing on April 14, 2025 on changing the zoning and subdivision regulations by amending the site plan approval criteria, and after deliberating voted to approve said changes.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GODDARD, KANSAS:

Section 1. Text and Image Change

ARTICLE 11. SITE PLAN REVIEW & BUILDING DESIGN STANDARDS

1.PURPOSE. The purpose of this Article is to establish requirements for Site Plan Review inGoddard and increase public participation in the design and physical development of thecommunity.

2.JURISDICTION. These regulations shall apply to all land located within the City of Goddard.

3.PROCESS.

a.Projects that present potential impacts to surrounding properties and neighborhoods go to the Planning Commission.

b.The Community Development Director shall make a determination if a project is to bereviewed by the Planning Commission

c.Plats are reviewed separately by the Planning Commission.

d.When required, a Site Plan Review application must then be submitted.e.Each submittal must include the information listed on the

f.After accepting your application for processing, the Com-

munity Development Director willreview the application for completeness.

g.If your application is found to be incomplete, you will be notified and asked to submit theadditional information required

to process your application. This may delay the schedulingof

your project for the Planning Commission.

h.The city maintains a listing of the Planning Commission Calendar for all applicants.

4.SITE PLAN APPROVAL

a.Applicability. All private and public principal land uses shall submit site plans and otherrequired drawings (See PART THREE) for approval by the Planning Commission exceptsingle-family and duplexes, unless the latter are arranged in courtyard or grouped settings. Such plans are applicable to all new developments and additions to all buildings. Principleland uses include major utility substations in all zoning districts. Minor revisions to the plans due to unforeseen circumstances may be approved by the Community Development Director after the initial plan approval by the Planning Commission. Site plans may be considered concurrently with applications for rezoning amendments and special uses. The Community Development Director provides applicants with the "Application for Site Plan Review", "Site Plan Review Criteria" and is available to explain and respond to questions on the process, contents and standards.

b. Applicants submit documents for preliminary or final review to the Community Development Director so that at least 25 days elapses between the submittal date and the regular meeting of the Planning Commission. If, in the opinion of the Community Development Director, the submittal documents contain significant errors or are incomplete, the application and documents will be returned to the applicant for required changes before they can be processed.

c. Once the application and documents are accepted, Zoning Administrator circulates copies of documents to other people as deemed necessary for technical review and comments before submitting them to the Planning Commission

d. The Planning Commission meets monthly to consider site plans. Applicants will be notified of the Planning Commission meetings. Meeting information is available on the City's website.

e. A majority vote is necessary for the Planning Commission to approve, with or without conditions, disapprove or defer for more study a site plan.

f. The Community Development Director will inform the applicant of the Planning Commission's decision. Any applicant aggrieved by a decision of the Planning Commission may appeal to the Governing Body within 30 days for a determination based on the reasonableness of the decision attached to the iss ance of their zoning permit No zoning permit shall be issued by City until final approval of the site plan has been given by the Planning Commission or upon appeal, the

Governing Body.

5. GENERAL REQUIREMENTS. All required information must be submitted in a digital format. The community development director or their designee may require additional information as is necessary to convey the ideas presented by the applicant.

To protect the health, safety and general welfare of the Community, the Community Development Director may require a licensed professional to prepare certain plans. A licensed engineer, for example, may be required to prepare a drainage plan when the City's storm water system is impacted by site development.

 a. Site Plan. A site plan is required showing the following information:

1) Scale and north arrow

2) Gross floor area of each building

3) Gross tract area4) Percent lot coverage

5) Building heights

6) All property and street pavement lines

7) Yards and building set back lines8) Fire lane easements (usually 20' wide) If necessary

8) Fire lane easements (usually 20' wide
9) Sidewalks and/or pedestrian ways

9) Sidewalks and/or pedestrian ways10) Utility easements and lines

11) Storm water structures, including possible retention/de-

tention facilities, and related easements or reserves.

12) Boundary and elevation of the 100-year flood, if appliants

13) Building pad minimum elevation

14) If parking is involved, show calculations for determining the required number of off-street parking spaces as required by the Zoning Regulations. Give the number of spaces actually proposed, including handicapped parking spaces. Give the maximum number of employees, customers, and office vehicles that would be at the facility at any one time.

15) Proposed ingress and egress to the site, including on-site parking areas(s), parking stalls, adjacent drives, and adjacent intersections.

16) Location and size of existing and proposed free standing

 b. Elevation view drawings. Elevation view drawings are required showing all relevant information to convey the information proposed.

c. Concept Images It may be determined that renderings or concept images are required to further convey the ideas of the developer.

d. Isofootcandle lines diagram. The Zoning Administrator shall make a determination whether the submittal of an isofootcandle diagram is required. When required, the diagram shall

include light output for lighted signage. See Part Four, Section C-3 k for guidelines.

6. Building Design.

Architectural style is not restricted. Evaluation of the appearance of a project shall be based on the quality of its design and relationship to surroundings.

Some limitations may apply which are listed below: Metal structures for primary or accessory buildings shall

have facing (wrapped) with material such as stone, brick, stucco or other approved materials. If any side is abutting a street or is considered significantly exposed to the public, it must be wrapped to the soffit level of the building. This shall be for Commercial and Industrial buildings only. Residential structures shall not be of rolled metal for primary residences. Rolled metal shall be acceptable for accessory uses to a residential property and must comply with Article 6. Anyone desiring to avoid this requirement either partially or in full can apply for a variance before the Planning Commission.

Section 2. Repeal Prior Provisions

All prior versions of Article 11 are hereby revoked.

Effective Date

This Ordinance shall take effect and be in force from and after its Publication in the official city newspaper.
