

Michigan Wolverines fire Derby football product Sherrone Moore as head coach

Sherrone Moore is no longer the head football coach at Michigan. In a stunning move Wednesday, the Wol-

verines announced that they decided to fire Moore for cause, citing an inappropriate relationship with a staff member as the reason why. “Following a university investigation, credible evidence was found that

Coach Moore engaged in an inappropriate relationship with a staff member,” Michigan athletic director Warde Manuel said in a statement. “This conduct constitutes a clear violation of University policy, and U-M maintains zero

tolerance for such behavior.” His situation could be more serious than that. Later on Wednesday, ESPN reported that Moore had been detained by police in Saline, Michigan. He was then turned over to the Pittsfield Township Police Department for an investigation into potential criminal charges. Moore, 39, was a stand-out football and basketball player at Derby High from 2000-04 before he made the leap to Butler Commu-

nity College and then Oklahoma. From there, he became a coach and rose all the way up the ranks until he was the head man at Michigan. More than two decades removed from his high school days, he still has Derby roots. He was inducted into the school’s athletic Hall of Fame in 2023. But his time at Michigan is over. His surprise firing sent tremors through the college football world when it

was announced Wednesday afternoon. Moore recently completed his second season as head coach with the Wolverines after previously serving as an assistant on Jim Harbaugh’s staff from 2018-2023. Michigan was 17-8 while he wore the headset, including a 9-3 mark this season. Michigan is scheduled to play Texas in the Cheez-It Citrus Bowl on Dec. 30 in Orlando.
