Attendance

The City Council of Columbus, Kansas met July 7, 2025, at 5:30 p.m. presided over by Mayor Grant Spieth. Council members present: Tom Pryor, Misty Spear, Laura Epler, Steve Dunlap and Kathy Doherty (via Zoom).

Council members absent: None.

Tom Pryor provided the Invocation followed by the Pledge of Allegiance.

Public Forum

Elizabeth Kutz, Robin Carson and Dr. Mindy Mayfield from SEK Animal Advocates approached the council requesting that the city consider a donation of \$25-\$50 per animal whenever they are rescued from the city dog pound by the SEK Animal Advocates. Kutz said the donation would help defray some of the expenses of feeding and transporting the animals by the volunteers. Dunlap asked City Administrator, Jake Letner to gather data regarding the number of animals housed at the pound in the past year for further discussion.

New Business 2026 Proposed **Budget Presentation.**

Administrator Jake Letner provided a proposed 2026 budget for all funds that have a mil levy, including the General Fund, Employee Benefits Fund, Library Fund, and Recreation Commission Fund. Letner suggested that the 2026 budget be considered at the September 2 City Council meet-

Consider Issuing a Notification to the Cherokee County Clerk of Intent to Exceed Revenue Neutral Rate for the 2026 Budget.

City Administrator Letner's budget proposal included a request for a mil levy of 60.0 mils, which exceeds the Revenue Neutral Rate. Spear made a motion to issue a notification to the Cherokee County Clerk of the city's intent to exceed the Revenue Neutral Rate for the 2026 budget, levying a total of 60.0 mils. The motion was seconded by Epler. Voting aye: Pryor, Spear, Epler, Dunlap, Doherty. Voting nay: None. Motion carried 5-0.

Consider Ordinance 1524 — Adopting Uniform Public Offense Code,

Pryor made a motion to approve Ordinance 1524 adopting the 2025 Uniform Public Offense Code and repealing Ordinance 1516. Epler seconded the motion. Voting aye: Pryor, Spear, Epler, Dunlap, Doherty. Voting nay: None. Motion carried 5-0.

Consider Ordinance 1525 — Adopting Standard Traffic Ordinance, 2025.

The approval of Ordinance 1525 adopting the 2025 Standard Traffic Ordinance was tabled until the next council meeting.

Consider Ordinance 1526 — Authorizing the Creation of a Vacant Property Registry. Code Enforcement Specialist Gary Holt opened the discussion regarding the creation of a vacant property registry. Holt stated the purpose of the proposed vacant property registration is to create a centralized, comprehensive database of unoccupied properties within the City of Columbus. Holt added that the registry will strengthen the City's ability to monitor vacant properties, enforce code compliance, and ensure proper upkeep. After discussion, Epler made a motion to approve Ordinance 1526, authorizing the creation of a vacant property registry with changes as noted. Spear seconded the motion. Voting aye: Pryor, Spear, Epler, Dunlap, Doherty.


