### **CITY OF GIRARD – ORDINANCE 1394**

Published August 7, 2025.

AN ORDINANCE AMENDING deemed expedient. ARTICLE 1, CHAPTER XIV OF THE CODE OF THE CITY OF GIRARD, KANSAS.

#### **ORDINANCE 1394**

An ordinance regulating traffic within the corporate limits of the City of Girard, Kansas; incorporating by reference the "Standard Traffic Ordinance for Kansas Cities," edition of 2025; with certain omissions, changes and additions; prescribing additional regulations; and providing certain penalties. Be it Ordained by the Governing Body of the City of Girard, Kansas:

Section 1. Section 14-101 of the Code of the City of Girard, Kansas, is hereby amended to read as follows:

INCORPORATING STANDARD

TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Girard, Kansas, that certain standard traffic ordinance known as the Standard Traffic Ordinance for Kansas Cities. Edition 50, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. No fewer than three copies of said Standard traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1394," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be

Section 2. Section 14-102, of the Code of the City of Girard, Kansas, is hereby amended to read as follows: SAME: TRAFFIC INFRACTIONS AND TRAFFIC OFFENSES.

(a) An ordinance traffic infraction is a violation of any section of this article that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. Supp. 8-2118.

(b) All traffic violations which are included within the ordinance, and which are not ordinance traffic infractions, as defined in subsections (a) of this section, shall be considered traffic offenses.

Section 3. Section 14-103 of the Code of the City of Girard, Kansas, is hereby amended to read as follows:

PENALTY FOR SCHEDULED FINES.

The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not be less than \$20 nor more than \$1,000. A person tried and convicted for violation of an ordinance traffic infraction or other traffic offense for which a fine has not been established in a schedule of fines shall pay a fine fixed by the court not to exceed \$1,000.

Section 4. AMENDMENTS. Section 114.2 of the STO 2024 is hereby deleted. Section 114.5 of the STO 2024 is hereby deleted.

Section 5. REPEAL. Ordinance number 1386 is repealed.

Section 6. EFFECTIVE DATE. This ordinance shall be in force and take effect from and after its approval and publication in the official city

#### **ORDINANCE 1393**

An ordinance regulating public offenses within the corporate limits of the City of Girard, Kansas; incorporating by reference the "Uniform Public Offense Code for Kansas Cities," edition of 2025.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GIRARD, KANSAS: Section 1. Section 11-101 of the Code of the City of Girard, Kansas is hereby amended to read as follows:

INCORPORATING UNIFORM PUBLIC OFFENSE CODE.

There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Girard, Kansas, that certain code known as the Uniform Public Offense Code, 39th Edition, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1393, City of Girard, Kansas," and to which shall be attached a copy of this ordinance and filled with the city clerk to be open to inspection and available to the public at all reasonable hours.

Section 2. REPEAL. Ordinance number 1385 is repealed. Section 3. EFFECTIVE DATE. This ordinance shall be in force and take effect from and after its approval and publication in the official city newspaper.


