

Titus Legislative Preview

The holidays are over, the kids are hopefully headed back to school, and ready or not, the 2026 legislative session starts on January 12th. For those of you who plan to visit the Capitol this year, please let me know in advance by email or by calling my office. I make it a priority to visit with constituents when they are in the Capitol or part of a group event, but I also travel home each evening and need your help to make sure I get everything on the calendar between children's practices and concerts. As always, please continue to reach out on the issues that matter to you. A short personal email explaining the impact of a bill is much more meaningful than sending a template email.

The Fiscal Situation

One of the key factors that shapes the course of legislation every year is the state budget. Family budgets are only getting tighter in the face of rising costs, so controlling state spending while protecting core services is my top priority.

Strengthening Your Family's Budget

Kansans can best decide how to spend their own money. Taxpayers are not better off when the state redistributes their hard-earned money, and over the last three years I've worked to help you keep more of your money. Here's a look at all the tax cuts that have passed (many over the veto of the Governor) in the last three years:

• Eliminated state sales tax on food;

• Eliminated state income tax on all income less than approximately \$30,000;

• Eliminated state income tax on social security;

• Eliminated personal property tax on recreational vehicles such as ATVs and electric wheelchairs;

• Eliminated 1.5 mills of state property tax; and

• Increased the dependent care deduction.

Protecting Key Services

The first (and a fair question) to ask after so many tax cuts should be about state revenues and a responsible budget. Last year, thanks to a legislatively led budget process, we cut State General Fund (SGF) spending by 2% or about \$200 million. The first cut in five years. Even with those budget cuts, we still increased funding for roads, water, education, and Medicaid. Leadership has indicated we should expect another 2% cut this year.

Last fiscal year was the first full fiscal year without the sales tax on food and with the income tax reductions, but revenue still exceeded projections by \$240 million for Fiscal Year (FY) 2025. In the current fiscal year, we are already \$47 million (7.2%) above projections. Long-term projections are also stable. Projections show the SGF will still have about \$1.2 billion in it by FY 2030 and there will be an additional \$2 billion in the rainy-day fund. We are cutting taxes, cutting state spending, protecting core services, and giving your family more financial choices.

Big Issues in 2026

Impact of the 2026 Election

2026 promises to be an interesting electoral year and that will have an impact on business in the Statehouse. So far, the Speaker of the House is running for Insurance Commissioner, the President of the Senate is running for Governor, two house members are running for Secretary of State, and two other Senators are also running for Governor. The prevailing wisdom is that that this will result in a quick session with attempts to limit the most controversial bills. As long as session is going on, these candidates are limited in the amount of time they can spend campaigning statewide and raising funds. It is hard to say how exactly this will impact the 2026 session, but it is certain that future electoral goals will impact motivations.

New Stadium for the Kansas City Chiefs

Perhaps the biggest headline this year was the announcement that the Kansas City Chiefs are moving to Kansas. This was made possible by a special STAR Bond bill that was passed in 2024. I voted against that bill and having seen the "deal" that the Governor negotiated and that our legislative leadership rubber stamped, I am appalled at the \$1.8 billion dollar handout. This doesn't even include the additional money that will support the government owned stadium collected from sports gambling and the other economic development incentives and tax credits that will be handed out to the Chiefs. The Chiefs are worth \$6.2 billion and the Hunt family is worth nearly \$25 billion. Subsidizing billionaire sports teams is not the State's job.

Congressional Redistricting

Many of you likely heard about the attempt to call a special session of the legislature to deal with congressional redistricting, driven mainly by national political concerns, and aimed at splitting up the 3rd District centered on Johnson County. No maps have been shared with legislators, and the House fell 10 signatures short of the number needed to call a special session. It is presumed any new maps would need 2/3rds approval in each chamber to override a veto by the Governor. If nothing changes, it appears unlikely there will be enough votes to pass new maps but expect the issue to come up early in the session.

Property Tax Relief

The biggest issue this year will likely end up being property tax relief. We failed to deliver meaningful relief last session, but progress was made as three different plans were circulated. I discussed all three at length last year, but as brief refresher, the proposed options include a cap on assessed valuation (taxable not appraised value) of property, limits on annual increases for municipal budgets combined with additional state funding for budgets below that limit, and establishment of a trust fund to be funded with money from the elimination of sales tax
